This course is designed for emergency physicians, residents, emergency nurses, physician assistants and nurse practitioners.

# ASSEMBLY OBJECTIVES

- List ideas for future research areas and topics.
- Discuss best practices in different aspects of emergency medicine
- Describe the epidemiology of common infectious diseases in travelers returning to the USA.
- Design an algorithm to evaluate fever in a recent traveler.
- Discuss the levels of isolation required for known and unknown infectious symptoms in travelers.
- Explain the support systems provided by local and federal officials to help with unexplained diseases.
- Describe the evidence for or against the use of intravenous fat emulsion in patients who have ingested lipid soluble toxins.
- Explain the risks of starting adults and children on opioids for an acutely painful event.
- Discuss the evidence to support gastrointestinal decontamination of poisoned patients beyond the traditionally quoted 1-2 hour threshold.
- Discuss the evidence available to choose between beta blockade and calcium channel blockade in the management of rapid atrial fibrillation.
- Identify a strategy to treat the hypotensive patient with an LVAD.
- Recognize poor prognostic indicators in patients who present to the hospital with CHF exacerbations and use these indicators to guide admission.
- Discuss the differences in mechanisms of injury between elder trauma patients and their younger counterparts.
- Explain how medications can impact the evaluation and treatment of elder trauma patients.
- Describe at least three types of elder abuse and how to recognize them.
- Discuss the differences between fast and slow thinking.
- List and explain at least three forms of cognitive error.
- Explain the “three stops” approach to minimizing medical decision making errors.
- Describe the different types of procedures used in bariatric surgery.
- Discuss the complications of the types of bariatric surgery and how these patients present to the emergency department.
- Explain the dos and don’ts when evaluating and treating post-bariatric surgery patients.
- Demonstrate the central role of sleep to the professional wellbeing of emergency physicians who are faced with sleep disruption due to night shifts.
- Identify characteristics of shift work sleep disorder, such as sleep latency times and recognize the importance for your personal wellness and safety.
- Discuss the pharmacologic approaches available to improve attentiveness and wakeful states on night shifts.
- Identify strategies to improve sleep hygiene and mitigate the adverse effects of night shift induced sleep disruption and circadian rhythm “blow out”.
- Recognize the relationship between the diagnosis of Idiopathic Intracranial Hypertension (IIH) and Cerebrovenous Thrombosis (CVT).
- Identify those patients at risk for CVT and correctly diagnose them with MRI/MRV.
- Describe the treatment strategies including newer interventional approaches.
- Recognize the findings for CVT on CT scan, and the serious limitations of CT in making the diagnosis of CVT.
- Define the issues related to identifying the number of penetrating injuries and the number of projectiles that will be found with imaging.
- Recognize the common injury patterns where NO projectile is found despite an entrance wound identified on physical examination.
- Identify the reasons that diaphragmatic injuries are challenging to diagnose with an ED evaluation of both GSW and stab wound victims.
- Distinguish injury patterns associated with penetrating trauma.
- Identify heart failure (HF) patients by their clinical profiles and phenotypes and assess comorbid conditions.
- Accurately diagnosis acute heart failure (AHF) based on clinical presentation, history, laboratory assessment, and radiographic findings.
- Interpret the data of related clinical trials and the evidence to support the use of current therapies as well as novel therapies that are in development for AHF.
- Collaborate with the interdisciplinary team to properly assess when HF patients need to be admitted to the hospital, placed in observation status, or discharged.
- Highlight the importance of early re-initiation of guideline-directed medical therapy, including beta blockers, and discuss the initiation or continuation of newer FDA-approved treatments for patients admitted to the hospital or placed in observation status.
- Describe evidence-based practices, including methods to improve care transitions for AHF patients once they are ready for discharge from the hospital.

## **Diane M. Birnbaumer, MD FACEP**

Senior Faculty, Department of Emergency Medicine at Harbor-UCLA Medical Center and Professor of Clinical Medicine at the University of California-Los Angeles

Dr. Birnbaumer is residency trained in both Internal Medicine and Emergency Medicine and is Emeritus Professor of Medicine at the David Geffen School of Medicine at UCLA. Dr. Birnbaumer was Associate Program Director at Harbor-UCLA Medical Center for nearly 20 years. Dr. Birnbaumer has presented over 2,000 lectures locally, nationally and internationally on clinical and educational topics, and has a particular interest in teaching the teachers. She has received several national awards, including the Outstanding Speaker of the Year and the Outstanding Contribution to Education Awards for the American College of Emergency Physicians.

## **Robert S. Hoffman, MD FAACT FACMT FRCP Edin FEAPCCT**

Director, Division of Medical Toxicology, New York University School of Medicine

Dr. Hoffman received his MD and completed a 3-year internship and residency in Internal Medicine followed by a Fellowship in Medical Toxicology all at New York University School of Medicine. He achieved Board Certification in Internal Medicine, Medical Toxicology, and Emergency Medicine. In 1989, Dr. Hoffman became the director of the Fellowship in Medical Toxicology at the New York City Poison Center and in 1994 he became the Director of the New York City Poison Center. In 2014, he became the Director of the Division of Medical Toxicology at New York University School of Medicine. Dr. Hoffman has authored over 250 peer-reviewed publications in various aspects of toxicology. He has been an editor of Goldfrank's Toxicologic Emergencies for the last six editions. He has held offices in all three American Toxicology Societies and is currently the past president of the American Academy of Clinical Toxicology.

## **William K. Mallon, MD DTMH FACEP FAAEM**

Professor of Clinical Emergency Medicine and Director, Division of International Emergency Medicine, Department of Emergency Medicine, Stony Brook University Hospital

Dr. Mallon has served as the Director of International Emergency Medicine at the Los Angeles County / University of Southern California Medical Center, and formerly its Residency Program Director for over 10 years. He has been a major influence in creating one of the highest ranked emergency medicine training programs in the country. His enthusiastic speaking style, combined with his solid knowledge base has resulted in speaking invitations throughout the United States as well as in Canada, Mexico, Great Britain, Italy, Iceland, Chile and Japan.

Dr. Mallon has worked extensively internationally and was a Fulbright Scholar to Iceland. He is considered a "Father of EM" in Chile, and got his Diploma of Tropical Medicine and Hygiene in Lima, Peru. He has lectured at and keynoted conferences in over 20 countries.

## **Phillip D. Levy, MD MPH FACEP FAHA**

Professor, Wayne State University School of Medicine and Associate Chair for Research, Department of Emergency Medicine

Dr. Levy serves as a reviewer for the NIH CHAS study section, a member of the Grants Advisory Panel for the Blue Cross Blue Shield of Michigan Foundation and a member of the Scientific Review Committee for the American College of Emergency Physicians. Dr. Levy is a recognized expert in cardiovascular research and has served on the National Heart, Lung and Blood Institute's Working Group on Management of Acute Heart Failure in the Emergency Department: Research Challenges and was as a member of the American Heart Association Scientific Statement Writing Group on Acute Heart Failure Syndromes - Emergency Department Presentation, Treatment and Disposition.

Dr. Levy's research interests center on heart failure and hypertension with a dual focus on acute management and early disease detection. He has been the Principal Investigator for grant projects funded by the Emergency Medicine Foundation, the Blue Cross Blue Shield of Michigan Foundation, the Robert Wood Johnson Foundation's Physician Faculty Scholars Program and the NIH/National Institute of Minority Health and Health Disparities. Over the past 10 years, Dr. Levy has published more than 100 manuscripts, authored 18 textbook chapters and has been an invited lecturer on cardiovascular disease related topics more than 200 times.



## WEDNESDAY, JULY 6

### Research Forum: Poster And Oral Presentation

Emergency physicians are faced with rapidly changing medical practices. Clinician needs to identify relevant studies from multiple different resources and decide which information to incorporate into clinical practice. This forum will review and discuss research projects primarily submitted from within New York.

### New Speakers Forum: Best Practices In Emergency Medicine

Emergency medicine is fast-paced and ever changing. National organizations such as the Institute of Medicine (IOM) and ACEP provide evidence-based guidelines and standards for various topics in medicine, from organizational recommendations to optimize emergency department throughput to clinical aspects such as STEMI and acute stroke. This forum of emerging dynamic speakers will provide clinicians with various evidence based best practices in emergency medicine.

### Case Reports in Travel Medicine

*Robert S. Hoffman, MD FAACT FACMT FRCP Edin FEAPCCT*

Rapid global travel increases susceptibility for remote infections to spread on a large scale. Recent years have seen novel infectious diseases such as SARS and MERS and the globalization of Ebola. Every emergency physician is faced with evaluating illness in someone who has recently traveled. This lecture will discuss the epidemiology of infections and other diseases in travelers and help each provider develop simple algorithms to evaluate and manage illnesses in recent travelers.

## THURSDAY, JULY 7

### The Heart Failure Management Paradigm: From the Emergency Department to Hospital Admission and Discharge

*Phillip D. Levy, MD MPH FACEP FAHA*

Emergency medicine clinicians and hospitalists have a unique, collaborative relationship in the continuum of care of acute heart failure (AHF) treatment and in providing optimal patient care from first point of access through hospitalization to discharge. This lecture will provide up-to-date evidence-based information on the clinical presentation of AHF, the importance of an accurate and timely diagnosis, and implementation of early therapeutic decisions. It will also address how to determine whether patients are to be admitted or discharged.

### Trauma in the Elderly Patient

*Diane M. Birnbaumer, MD FACEP*

Trauma in the elder patient is a different animal when compared to trauma in younger patients. Mechanisms and patterns of injury differ, and medications and coexistent medical problems make caring for these patients a challenge. This lecture will cover the highlights of these issues as well as touch on elder abuse.

### Penetrating Trauma: Do The Holes Add Up?

*William K. Mallon, MD DTMH FACEP FAAEM*

Penetrating trauma can sometimes lead to complex injury patterns. Understanding diagnostic pitfalls is critical to the timely diagnosis of life-threatening injuries. Injury patterns with various combinations of entry and exit wounds will be discussed including a few forensic pearls regarding EP charting and the collection of evidence for law enforcement professionals. We will also review various imaging strategies in patients with penetrating trauma. Finally, pitfalls in the diagnosis of diaphragmatic injuries following gunshot wounds and stab wounds will be discussed.

### Toxicology Literature Update

Robert S. Hoffman, MD FAACT FACMT FRCP Edin FEAPCCT

Toxicology is a rapidly expanding discipline whose publications are scattered across many journals. As such it is a challenge to keep up on current trends in the literature. This lecture will discuss the most recent toxicology papers that directly relate to emergency medicine practice.

### FRIDAY, JULY 8

#### Cerebrovenous Thrombosis (CVT): The Venous Side of Stroke

William K. Mallon, MD DTMH FACEP FAAEM

Cerebrovenous thrombosis (CVT) is a potentially devastating neurologic emergency in which the diagnosis is often delayed. This lecture will help you identify the patients at greatest risk for CVT. The diagnostic test used for CVT will also be discussed. Although some findings may be seen on CT, this lecture will emphasize the need for timely MRI/MRV to correctly make the diagnosis. Finally, new treatment strategies, including interventional approaches will be discussed.

#### Medical Decision Making and Medical Error

Diane M. Birnbaumer, MD FACEP

The science of decision making has shed light on where medical practitioners often stumble when making medical decisions. This lecture will focus on how practitioners think, where cognitive errors can happen and will offer solutions for minimizing medical decision making errors.

#### Sleep Science for the Emergency Physician: Be a Professional

William K. Mallon, MD DTMH FACEP FAAEM

Obtaining an adequate amount of quality sleep is essential to the emergency physician. However, irregular schedules and nights shifts pose a significant threat. This lecture will emphasize the importance of obtaining adequate sleep as it relates to wellness and safety. Learners will also be introduced to the concept of shift work sleep disorder. Additionally, both pharmacologic and non-pharmacologic approaches to improving sleep hygiene will be discussed.

#### Atrial Fibrillation

Robert S. Hoffman, MD FAACT FACMT FRCP Edin FEAPCCT

The evaluation and treatment of atrial fibrillation and congestive heart failure is constantly undergoing revision as new evidence is produced. This lecture will use an evidence-based approach to provide clinicians with the tools they need to manage these common problems. Specific items for discussion include rate control agents, indications for hospitalization, management of patients with left ventricular assist devices and techniques to help reduce 30 day readmissions.

#### Bariatric Surgery and the Emergency Practitioner

Diane M. Birnbaumer, MD FACEP

Patients are increasingly turning to bariatric surgery to address the obesity epidemic in the United States, undergoing procedures ranging from minimally invasive techniques to major surgery. When these patients present to the emergency department with abdominal pain, the cause may be as minor as post-surgical pain to life threatening internal hernias. This lecture will demystify these procedures and explain the approach to the evaluation and treatment of these patients.
